A festive holiday to one and all and no doubt we will be in touch in 2007!!





## PICS Annual Meeting 2006

The PICS annual scientific meeting was held in Glasgow on 16-17<sup>th</sup> November. It was notable that PICANet has become a valuable source of information for the PIC community and a strong collaborator with the PICS study group.

#### **Informatics**

It was heartening to see a number of presentations on the use and development of clinical information systems in PICU, at the PICS Annual Meeting in Glasgow. During the conference, preliminary results from the pan Thames Health Informatics Group (PHiG) Survey were presented at the PICS Study Group (PICS SG) session and received with interest.

The survey is to be expanded across all UK sites as a PICS SG study, in order to establish current levels of information technology use and availability. Data on PICU computerisation is sparse and a survey of this nature will establish a baseline understanding of facilities available to clinical and administrative users. The survey is intended to inform strategic planning and research and development in this field for the future.

All PICANet units will be contacted soon; unit leads are encouraged to participate in the survey, the results of which will be presented at the PICS SG meeting in March 2007.
