## NET-PACK 3 CUSTOM AUDIT

NET-PACK 3 Custom Audit - PICANet evaluation of Post cardiac Arrest Care in Kids. NET-PACK 3 is a re-audit of patient management after cardiac arrest in UK and Irish PICUs following the collection of NET-PACK 2 data that ended in 2015.

NET-PACK 3 has been designed to investigate the impact and compliance with the new International guidance and research data on post-arrest care as part of our clinical audit function. NET-PACK 3 is intended to assess the effect of the International Liaison Committee on Resuscitation (ILCOR) recommendations on Paediatric Advanced Life Support and post-cardiac arrest management and recent clinical trial evidence on the post-arrest management of patients.

If your data request includes data from English PICUs:

### Step 1:

Please complete the PICANet online request form as usual. PICANet will send your data request to our Clinical Advisory Group for comment and approval after we have checked it is feasible. **Step 2**:

HQIP have two forms which need completing: a data access request form and a data sharing agreement. Guidance on the HQIP data access process and the required forms are available on the <u>HQIP website</u>.

The HQIP data access request form must be signed by PICANet before HQIP will consider the request. This means you must send PICANet the completed HQIP data access request form.

### **RCP** ASTHMA AUDIT

The Royal College of Physicians (RCP) is undertaking a development project to inform the specification of, and conduct the foundation work needed for, a national asthma audit.

The project will include development and piloting of core adult and paediatric datasets, and exploration of how primary care information could be incorporated to provide a complete picture of the asthma care pathway. The asthma project team are currently recruiting hospital pilot sites, including specialist paediatric hospitals, within England and Wales for an autumn 2017 pilot to test all proposed questions in a real life clinical setting. Data will be collected at the point of discharge to reduce clinical burden and these hospitals will have the unique opportunity to be actively involved in the development of the audit.
