PICANet Annual Meeting

PICANet Web

The new web based system launched on the 1st October, 2011. So far 19 units have successfully transferred their unit data to PICANet Web and 6 units have contacted the PICANet IT team to discuss the transfer process. The remaining units will be contacted to establish timelines.

PICANet Web: User access

Following approval by CAG levels of user access has been split into the following three levels:

Writer: Users have full read/write access to

their own organisation's data.

Reader: Users have read-only access to

their own organisation's data.

Reporter: Users have access to Dashboard

and Reports only.

Clinical leads have been contacted to confirm the levels of access for those users already registered with PICANet.

PLEASE NOTE: usernames and passwords MUST NOT be shared.

Validation Query Reports

Units that have transferred to PICANet Web are able to generate their own validation reports at any time. Since the launch of the system there have been a number of updates to the validation reporting tool including the addition of validation queries not previously generated for data entered

onto PICANet DE. We would like to draw your attention to the following in particular:

Validation Reports: Clicking the export function will enable you to download the report in different formats.

Date of Discharge: Completion of the 30 day follow-up status for patients discharged from PICU to 'normal residence' is now required. For PICANet DE this information was not collected.

PICANet Web reporting

The admissions graph shown on the home page plots the number of admissions to your unit. If you hover over a bar the number of admissions for the month will appear.

Referral & Transport Data

The 1st of January 2012 marks the official start to the data collection for the retrieval datasets. Referral and transport data should be submitted by the PICU or Centralised Transport Service taking the referral call and or providing the transport. All clinical leads have been sent copies of the data collection forms and a data definitions manual. Contact picanet@leeds.ac.uk.if you have any queries.
