#### What does PICU offer the family?

Following this, PICANet wish to undertake a brief survey of units, to determine the type of information and facilities available to parents and families, whilst their child is a patient in the paediatric intensive care unit.

## The Refractory Convulsive Status Epilepticus Study

PICANet are coordinating the collection of data for this important study, funded by the Epilepsy Research Foundation, into the incidence, aetiology, treatment and outcome of children admitted to PICU in refractory convulsive status epilepticus. The study is running from January 1<sup>st</sup> 2008 – December 31<sup>st</sup> 2009 in conjunction with Richard Appleton and Tim Maitland,

Consultant Paediatric Neurologists, Alder Hey Children's Hospital and Manchester Children's Hospital respectively.

Thank you to those units who are routinely checking and identifying cases for the study. Twenty-one units initially agreed to take part. However we would welcome any additional units who are interested in participating. We expect that individual units will only admit a small number of children who fulfil the inclusion criteria for the study therefore in order to collect the total numbers of cases required we need to recruit cases from as many units as possible.

A single questionnaire requires completion, for all admitted children fulfilling the study criteria and the data can be extracted retrospectively from the medical records so there is still time to become involved. Each participating PICU will receive £25.00 per child for whom a completed questionnaire is returned to the PICANet Leicester office. #### PICANet IT Future

The team are planning a major revision of the IT infrastructure that allows collection and reporting of the PICANet data. To keep up with the times, we are proposing to develop web-based data entry that will enable 'live' input of data and instant feedback. This will mean better control of updates that can be performed centrally and the opportunity to 'add-on' local, regional or national data collection modules to facilitate research and audit of specific topics (e.g. clinical trial data or short-term surveys). We will be consulting with the PIC community on what features should be included in the long and short-term.

Please be ready to contribute suggestions on the content and format of the reports produced. The aim is to make access to your data and comparative national data much easier.

The new retrievals dataset developed by Allan Wardhaugh and approved by PICS will be integrated

with this new web-based technology. There will also be the benefit of local reporting tools that can provide data alongside national benchmarks, all on-line.

There is considerable security and technical issues to overcome but we have strong support from HQIP, our funders. They see this as the way forward for all national audits.

In the short term, we are going to provide a simple web-based interrogation tool that will access an anonymised version of your data and aggregated information based on the national dataset. This will provide baseline information on your activity with a national comparison and will be updated as new data are sent to us and processed.
