PICANET STAFF

PICANet appointed a new statistician, Hannah Buckley, who started February 2019. We are pleased to welcome Hannah onto the team. Hannah is a Senior Statistician and has previously worked in Clinical Trials. Hannah is looking forward to working alongside members of the PIC community.

### GET IT RIGHT FIRST TIME (GIRFT)

Getting It Right First Time (GIRFT) is a national programme designed to improve the quality of care within the NHS, by tackling variations in the way services are delivered across the NHS, and by sharing best practice between trusts.

Kevin Morris and Peter-Marc Fortune have been appointed to lead a GIRFT review of Paediatric Critical Care, a project jointly sponsored by NHS I (GIRFT) and NHS E (National Review team). They plan to review PICU services and Paediatric Critical Care Networks across England, as well as a number of Level 2 (HDU) units. They plan to centre the review process on an evaluation of 'what does good look like?' The process will involve 1) sharing of a data-pack for each service/network based on information derived from a number of data sources, including PICANet, as well as information provided through a questionnaire, followed by 2) a peer review visit of each service. A local report will then be generated which it is hoped will allow each Trust to focus on areas of potential gain. Local GIRFT implementation teams will work with Trusts to assist them in achieving these goals. Finally a national overview report for Paediatric Critical Care will be published making a number of key recommendations for services across England. It is anticipated that questionnaires will go out to Trusts in autumn 2019, ahead of visits in early —mid 2020 and a final report published before the end of 2020.

The PICANet Audit is commissioned by the Healthcare Quality Improvement Partnership (HQIP) as part of the National Clinical Audit Programme (NCA). HQIP is led by a consortium of the Academy of Medical Royal Colleges, the Royal College of Nursing and National Voices. Its aim is to promote quality improvement, and in particular to increase the impact that clinical audit has on healthcare quality in England and Wales. HQIP holds the contract to manage and develop the NCA Programme, comprising more than 30 clinical audits that cover care provided to people with a wide range of medical, surgical and mental health conditions. The PICANet Audit is funded by NHS England, NHS Wales, NHS Lothian/National Service Division NHS Scotland, and the Royal Belfast Hospital for Sick Children, The National Office of Clinical Audit (NOCA), Republic of Ireland and HCA Healthcare.
